2. In the letter first read above, the State Planning Commission has recommended on the proposal of setting up of Smart Class using all in one ICT Technology in selected schools in the State as follows:-

If provided timely with the hints of how to improve. Clues on how to improve provide timely and precise feedback and stretch them gently will give them a sense of achievement. All-in-One ICT Kit combines a hi-tech projector with a PC, a DVD writer, a TV tuner, in-built speakers, a 500 GB HDD, 3G-internet, a wireless keyboard and a mouse. The hi-tech innovations built into one unit, the Kit remains a compact teaching aid designed to enable a teacher to focus on teaching rather than technology. At the touch of a button the teacher can toggle between multiple media like PC, TV and Internet to bring about an immersive classroom experience to the students. The total project cost is Rs.64.06 lakhs. The School Education Department over the years in partnership with SCERT has evolved numerous digital content with respect to multimedia images, videos, on VI-XII curriculam. When these multimedia images and digital content are added in addition to the regular textbook, this will help students not only to participate effectively in classroom teaching-learning processes but will held them to acquire clarify on the subject learnt/taught, besides helping them to score high marks in Public

Examinations. Therefore, the State Planning Commission after detailed appraisal has recommended the proposal.

3. In this connection, the Director of School Education in the letter second read above has submitted that, the use of computer in Secondary Schools is All-in-One ICT Technology signifies knowledge vehicle is one of the core technology components. The All-in-One ICT Kit combines a hi-tech projector with a PC, a DVD writer, a TV tuner, in built speakers, a 500 GB HDD, 3G internet, a wireless keyboard and a mouse.

The projector and PC included, allows the school to use it for many other activities, like teaching computers, making Power Point presentations, and even for screening movies and event videos. The kit is portable and less cumbersome to set up compared to laptops attached to projectors or fixed infrastructure like electronic white boards. Moreover, it can also be used outside classrooms for special events and movie shows. The spacious hard disk storage allows the school to store unlimited content in the form of multimedia, movies, school videos and project, songs, etc. The DVD player and the multiple USB ports allow external content to be viewed on the Kit. Further the Directorate of School Education over the years in partnership with SCERT has evolved numerous digital content with respect to multimedia images, videos, on VI-XII curriculum. When these multimedia images and digital content are added in addition to the regular textbook, this will help students not only to participate effectively in classroom teaching-learning processes but will held them to acquire clarity on the subject learnt/taught, besides helping them to score high marks in Public Examinations.
